# Seat 1-- Person with lived experience, 2015-17:

- Hanna Adams- Hanna Adams serves as Executive Director with Central Texas Opportunities, Inc. (CTO) and oversees various grants to assist low-income people and communities in breaking the cycle of poverty in a seven-county service area. She joined CTO in 1998 as a case manager. She is now a Nationally Certified Results Oriented Management and Accountability Trainer, a founding board member for Brown County Home Solutions, and a Conference Chair for the Texas Association of Community Action Agencies. Hanna is proud to be part of an organization that has assisted in transitioning 250 people out of poverty over the last 5 years. Hanna's real life experience gives her the ability to make program and procedural decisions that are in the best interest of the people she serves.

## Seat 2 - Homeless Veterans, 2015-17:

- Bobby Ehrig- Bobby Ehrig is a Program Manager of Veterans Services (South Texas Region 1) with Family Endeavors. He brings 5 years of experience working with Veterans and homelessness, and is a combat-wounded veteran of 17 years. Bobby has also been a member of the state Veteran's advisory board for 2 years, and has championed the passing of two state laws supporting severely injured Veterans in 2011 and 2013. He is now helping to develop 3 LHCs in rural south Texas as he continues to manage homeless assistance programs serving Veteran and families in 23 counties of south Texas. Bobby states that he would "like to continue helping to build collaborations and develop strategic planning that can create far reaching solutions to homeless programs and issues" and believes that "by teamwork we can tackle and succeed at overcoming any obstacles that prevent the homeless from being productive members of society."

### Seat 3 – Chronically homeless persons, 2016-17:

• Chad Wheeler- Chad Wheeler is the Executive Director and minister of Carpenter's Church in Lubbock. He is a homeless community developer with nine years of experience leading a faith-based community organization serving people experiencing chronic homelessness. Chad led the development of the first Housing First project targeting chronically homeless individuals in Lubbock. He has a passion for Housing First, creative development, community organization, and collaborative poverty alleviation. Specializing in organizational management and holistic

strategies for ending homelessness, Chad wants to serve on the CoC Board to learn more about the Texas Balance of State and to help support the growth and development of lasting strategies for preventing and ending homelessness in the TX BoS communities. He currently serves as the President of the South Plains Homeless Consortium.

#### Seat 4 - Homeless families, 2016-18

- Jesse Elizondo- Jesse Elizondo is the Social Services Director of The Salvation Army of Corpus Christi. He has been working with homeless families for 8 years. Salvation Army is the only agency in Corpus Christi to house intact families and single fathers, keeping households together as they come. The Salvation Army has been an ESG recipient since its creation, and Jesse has directly supervised and implemented policies to ensure program compliance. He believes that homeless individuals and families deserve great customer service, and has an eye for eliminating policies and procedures that don't make sense. He wants to serve on the Board to continue assisting others and to continue working with a great group of individuals who share his passion of helping the homeless. Jesse has already completed one term of service on the TX BoS CoC Board and has served as the Chair of the Homeless Issues Partnership Inc. for 5 years.

She further believes that her service on this board will add two perspectives that of a faith-based organization and of a community funder. # Seat 15 – Texas Interagency Council for the Homeless (TICH) or State government agency, 2016-17

- Molly Voyles- Molly Voyles is the Public Policy Manager at the Texas Council on Family Violence in Austin. Through her experience, she has seen how effective collaboration and coordination can assist all members of the homeless community. She has worked in the field of domestic violence for nearly 25 years, including 10 in public policy and 10 in HUD funded domestic violence programs, and throughout that time has seen survivors of family violence routinely say that access to housing and supportive services rank as their top unmet need. Molly is aware of the federal priority to end family homelessness by 2020 and has seen that statistics show the vast majority of families experiencing homelessness have experienced domestic violence. She wants to serve on the CoC board to lend insight and support on domestic violence as the Board addresses that priority and to support the broader mission of the CoC. She has served on the Texas Interagency Council on Homelessness (TICH) for a number of years and is also the lead on the comparable database for victim service providers in Texas.
