All seats are elected for a two-year term, from October 2018 through September 2020

### Seat 2 – Homeless Veterans:

- **MELISSA ESCAMILLA**

**Position:** Program Director at Endeavors

**Experience:** I currently serve as the Program Director for the Veteran Supportive Services Program at Endeavors in McAllen, Texas. We provide services to at-risk and/or homeless veterans in over 20 counties in South Texas.

Aside from working at Endeavors with homeless veterans, I also come from a veteran family and am aware of the challenges a veteran may face once they have transitioned out of the military. Some challenges may include disability, substance use disorder, income, mental health, and the lack of affordable housing.

Currently I serve as the Vice Chair of the Cameron County Homeless Coalition and participate in homeless coalitions across South Texas including Corpus Christi and Laredo.

**Reasons nominee wants to serve:** This past year I served as a board member representing homeless veterans in our continuum. I would like to continue to serve on the board to help advocate for homeless veterans within our continuum and promote any services our continuum can offer homeless veterans. I am passionate and dedicated to working for and with veterans with disabilities, homeless veterans and veterans in general.

I also am a board member of the Community Veteran Engagement Board in the Rio Grande Valley. As a board member I advocate for homeless veterans by educating and informing others, including the Veteran's Administration, about the needs of our veterans, including affordable, sustainable, and accessible housing, lack of community services, and barriers our veterans encounter.

I am a team player and encourage collaboration on all levels. I feel my approach to solving problems or providing options for homeless veterans will enable our communities to end homelessness among veterans.

**Other information:** I have over 16 years of experience working with special populations including people with disabilities and veterans. In May 2019 I will acquire my Doctor of Philosophy in Rehabilitation Counseling. With my PhD, I plan to continue to help at risk and homeless veterans, acquire my license in professional counseling.

I spent 13 years working with people with disabilities and currently the last three years with the veteran population. Last year, our team (Endeavors) and I were able to help veterans who were displaced and affected by Hurricane Harvey. We worked with our community partners to identify and house veterans who were displaced due to Hurricane Harvey.

In addition to my experience I am a mom to a combat active duty serviceman and come from a combat veteran family. I am hard working, dedicated, patriotic and passionate towards

John served in the United States Marine Corps. He worked as a Math/Special Education Teacher in Texas for 8 years. John personally experienced homelessness in 2014 that led him to seek services from the Veterans Administration and SSVF. Since that time he has pursued the goal of making homelessness, “rare, brief, and nonrecurring” for Veterans in 25 counties in the Texas Balance of State Continuum of Care.

**Reasons nominee wants to serve:** John Meier wants to be involved in the continuing growth of services offered within the Texas Balance of State Continuum of Care, as well as continuing improvements in processes for delivering those services.

**Other information:** John Meier has tremendous experience building community collaboration and instituting system changes. John Meier's WCTRF-SSVF goal is to End Veteran Homelessness and getting to functional zero for Veteran Homelessness in the 25 counties served within the next year and half.

**Other information:** I am currently serving on the Maricopa Association of Governments CoC board and chair the Coordinated Entry Subcommittee in Phoenix. I believe I can be helpful to the Balance of State of Texas by providing perspectives from other areas of the country to help meet the goals of ending veteran homelessness.

- **KATHERINE BISSON**

**Position:** Executive Director at Abilene Hope Haven

**Experience:** I have years of experience working with families. Before my current organization I worked at a youth shelter that served homeless, runaway, trafficked, and those involved with the juvenile justice system. We would intervene, and if possible, reunite with family/guardians. I have also worked for Communities in Schools as the dedicated homeless student intern where I assisted with attendance, education, self-esteem, and family conflict/crises. As a Rapid Rehousing case manager I worked closely with the homeless liaison and other community resources for the children, as well as working closely with the Texas Department of Family and Protective Services as an advocate to leverage resources.

**Reasons nominee wants to serve:** I am the Vice Chair of our LHC (West Texas Homeless Network). I am also involved in many other community groups. I want to serve on the CoC Board to not only contribute my experiences, but also to gain more insight on a larger system level to better inform our programs and these community-wide efforts. I believe this will assist in making homelessness rare, brief, and non-recurring.

**Other information:** After receiving my Bachelor in Business Administration, I switched gears to pursue my Master of Science in Social Work. This shift was made by my desire to work specifically with children and families. I am motivated in my current position to ensure that families experiencing homelessness and connecting them to the resources that will best meet their needs. In addition, I adopted and know the importance of family of all types. I have a heart for families experiencing homelessness and would be a great advocate in this role.

I have also served on committees and expert panels in the field of domestic violence at local and statewide levels.

I have been able to use my experience working with victims to aid in creating a system in our community that is not only safe for everyone, but also empowers them to make stabilizing decisions for their future.

**Reasons nominee wants to serve:** Over the past year of working with the Texas Homeless Network and the CoC in bringing a coordinated effort to addressing homelessness in our community, I have seen the impact that stable housing can have for victims. Housing first can jump-start a victim's path to securing the future that they seek for themselves. Affecting that level of change on a larger scale would be an incredible honor and responsibility. I consider my life's work to be advocating for those who have been marginalized and feel their voices are not heard. By serving on the CoC Board, I would work to increase that voice for victims throughout the Balance of State.

**Other information:** During my graduate studies in Public Health, I chose to focus my studies on Community and International Health. While there, I learned that the health of individuals is largely related to the community's actions as a whole in the pursuit of health. I feel that the Texas Balance of State Continuum of Care is a large community, and by taking responsibility to advocate for the issue of homelessness in our community, the impact on individuals will be

This experience includes direct patient care for more than 10 years and the last 5 years, I have actively participated in improving Public Health in the South Texas region. As part of my post graduate education (Master in Public Health), I developed programs to modify and improve Social Determinants for at risk populations as the homeless, drug addicts, veterans, social and racial minorities. My experience in disease investigation, prevention and control has given me a deep understanding of the importance of human living environments. Homeless situations or below standard living conditions determine health and social outcomes. Most, established a direct relationship between housing deficiencies and the incidence rate for some diseases.

**Reasons nominee wants to serve:** I would like to serve this organization because I can provide my expertise in Public Health and disease prevention. At the same time, I would be able to provide up to date information on important emerging public health threats and the latest disease trends and behavior. Access to health care prevention services for at risk populations will also be important part of the knowledge that I can provide to this important organization. Providing affordable dignifying housing should be a priority for thriving societies as well as provide access to health care and preventive services. Families and individuals need those two basic important factors to overcome difficult situations as drug addiction, poverty, mental health issues, and devastating diseases such as tuberculosis. I can give my input and knowledge to this organization to develop better plans and policies in regards to housing in Texas.

**Other information:** I am a professional Public Health individual with post-secondary education. I am an advocate for improving the standards of living. My background is multicultural since I have lived in three different countries in the course of my life. I have visited the poorest communities in our Continent as well as the wealthiest neighbors. I understand that housing is a basic principal and foundation for human development. I am also an advocate for children's rights and I believe that social determinants for our children should at least reach a minimum acceptable level. Housing and health must be the stepping stone for social development. Our commitment with these two principles as society shouldn't be short term investments rather midterm and long term sustainability. I work on a daily basis with population that cohabit in poor living conditions (homeless, veterans, children, low socioeconomic, rural and drug addicts) and I consider housing as the most important social determinant of health.
