Recruiting Independent Review Team Members

The TX BoS CoC is recruiting Independent Review Team (IRT) members to assist in reviewing and scoring applications submitted under the FY24 Local Application Process for the CoC Program. IRT members can expect a 1-2 hour training session prior to reviewing applications. The total time commitment is expected to be less 10 hours during the months of August or

September. IRT members will receive compensation of \$75 per application that is reviewed and scored with a maximum of 5 applications per member.

PLEE and Data Decision-Making Toolkit from HUD



The U.S. Department of Housing and Urban Development (HUD) has released a toolkit to guide CoCs and Persons with Lived Experience and Expertise (PLEE) of Homelessness on data projects and data decision-making. "CoCs should work together with PLEE to engage in collection, review, analyzation, and use of data to make collaborative decisions impacting their local community...The insights and experiences of PLEE are crucial to the development of effective, responsive, and compassionate solutions to this complex issue. By sharing PLEE experiences, ideas, and data interpretations, PLEE can help shape the response systems that will ultimately impact the future of individuals in similar situations. PLEE input can help to create a more equitable and just society, where everyone has access to the resources they need to thrive."

NAEH Webinar on Reimagining Emergency Shelter

The National Alliance to End Homelessness (NAEH) will host a webinar entitled *Emergency Shelter: Reimagining a Housing Focused Place People Want to Use* on Thursday, **May 16th, from 2:00-3:30 CDT**. "A safe, welcoming, low-barrier, and housing-focused shelter is a critical component of an effective homeless response system. Effective shelter practice requires listening to people with lived expertise and making cultural, philosophical, and operational shifts according to their feedback. This webinar will discuss modifying entry protocols, lowering barriers, and rethinking service provision to adopt housing-focused approaches."

Funding & Other Opportunities

Anti-Trafficking Housing Assistance Program

The purpose of this program is to develop, expand, and/or strengthen funded organizations so they can provide housing and associated support services to victims of human trafficking.

Applicants are invited to apply under two program purpose areas.

Purpose Area 1: Developing Capacity to Serve Human Trafficking Victims

Under Purpose Area 1, OVC expects to make up to six awards of up to \$600,000 each for a 36-month period of performance to begin on October 1, 2024.

Purpose Area 2: Enhancing Scope of Housing Assistance for Human Trafficking Victims

Under Purpose Area 2, OVC expects to make up to 11 awards of up to \$1.2 million each for a 36-month period of performance to begin on October 1, 2024.

Housing-Focused Street Outreach Webinar Series: System Support for Housing-Focused Street Outreach

Street Outreach serves a critical role in the homeless response system, often reaching people who aren't accessing services in any other way. Incorporating a housing focus into street outreach programs improves outcomes for persons experiencing unsheltered homelessness by eliminating the need to first enter emergency shelter, and instead directly connecting them to safe, stable, permanent housing. Implementing housing-focused street outreach requires a shift from the historical practices of outreach that have focused primarily on addressing basic needs and connection to shelter through light touch services to a more trauma-informed and service intensive model that includes housing navigation

Staff Recommendation

The National Low Income Housing Coalition (NLIHC) has released two annual documents: *The Advocates' Guide* and *The Gap*.

The [Advocates' Guide 2024: A Primer on Federal Affordable Housing and Community Development Programs and Policies](#) is a reference work about federal affordable housing programs and policies. Affordable housing is key to ending homelessness. Chapters 4 and 6 include articles about homelessness, such as McKinney-Vento homeless assistance, using federal surplus property to address homelessness, criminalization of homelessness, and shelter access for transgender people. Learn more about federal programs so you can effectively advocate for them.

[The Gap: A Shortage of Affordable Homes](#) "presents data on the affordable housing supply and housing cost burdens at the national, state, and metropolitan levels. The report also examines the demographics, disability and work status, and other characteristics of the extremely low-income households most impacted by the national shortage of affordable and available rental homes." The report shows that there is a shortage of 7.3 million rental homes affordable and available to the lowest-income renters. Learn more about the gap to help you advocate for more housing.
