

Request for Proposals: Written Standards for Service Delivery

The Texas Balance of State Continuum of Care (TX BoS CoC) seeks proposals to update its Written Standards for Service Delivery, emphasizing inclusivity and equity. The goal is to create standards that reflect the diverse needs of communities, address racial disparities, and promote culturally responsive and fair practices. Stakeholder feedback, including from those with lived experiences, will be integral to this process. The project budget is \$60,000, running from 10/01/2024 to 08/31/2025. **Proposals are due by 12/09/2024**.

2024-25 CoC Board Nomination Period is Open

The CoC is accepting nominations for seven board seats:

Seat 2 - Homeless veterans

Seat 4 - Homeless families

Seat 6 - Victim services

Seat 7 - Health/medical

Seat 10 – Emergency Solutions Grant (ESG) Program recipient

Seat 12 - Law enforcement/criminal justice

Seat 14 – Faith community or faith-based organization

Voting will occur in February 2025.

The term of service will be April 1, 2025, through March 31, 2027 (24 months).

The CoC Board plans to meet in person in Austin in April 2024 for an orientation session and then once per month for 1.5 hours by Zoom.

Background:

The CoC Board is the main decision-making body of the CoC. It determines the policy direction of the CoC and ensures that the CoC fulfills its responsibilities. Additionally, the board oversees the work of CoC committees and the CoC Collaborative Applicant and HMIS Lead Agency (Texas Homeless Network). Board members also stay informed about how the CoC is performing to prevent and end homelessness, and they serve as liaisons between the CoC and the communities and sub-populations they represent. Board members comply with a code of conduct, conflict of interest policy, and confidentiality policy.

Seat 1 is filled by a person with lived experience of homelessness. Seats 2-15 are filled by people who represent the stakeholder groups designated for those seats by:

Being a member of that group (for example, Seat 2 could be filled by a currently or formerly homeless veteran); and/or

Working for an agency/organization that serves the designated group; and/or

Clearly representing the interests of that group, as evidenced in the nomination form.

The Board needs members with varying skills, expertise, and backgrounds to represent the diversity of people experiencing homelessness in the CoC. Anyone who lives and/or works in the <u>TX BoS CoC's geographic area</u> is a general member of the CoC and may run for a seat on the Board.
